### **PRIVACY RULES**

You always have control over your data, and you can opt out of further receiving marketing communications in the same way as you agreed to.

We will keep your information within our company and our confidential third parties, except in cases where disclosure is required by law, for example to government bodies and law enforcement agencies.

# HOW LONG WILL WE KEEP YOUR DATA?

Your personal data will be kept for the period necessary to fulfill obligations from the law, contract or in accordance with the intended purposes of collection.

Your personal data for marketing communications will be kept for the period of your consent.

## WHAT RIGHTS DO I HAVE OVER MY PERSONAL DATA?

According to the General Data Protection Regulation, you have the right to request from us:

- the right to access you have the right to contact us at any time and get confirmation as to whether your personal data is being processed and, if this data is being processed, to request access to personal data and information to which you are entitled in connection with the protection of personal data. BELINA d.o.o. It provides you with a copy of the personal data being processed, and for any additional copies you request, we may charge you a reasonable fee based on administrative costs. If you submit a request electronically, unless you request otherwise, we provide the information to you in the usual electronic form;
- the right to correction if we process your personal data that is incorrect, you can ask us to correct it at any time, and if it is incomplete, you have the right to complete it;
- the right to deletion you have the right to ask us to delete personal data relating to you if we have illegally processed them or if personal data are no longer necessary in relation to the purpose of processing or similar. Please take into account that there are reasons that prevent immediate deletion, for example in order to establish, realize or process legal requests, which we will inform you about in detail in relation to each individual request;
- the right to limit processing you can ask us to limit the processing of your data:
- if you dispute the accuracy of personal data during the period that allows us to verify the accuracy of such data,
- if the processing is illegal, but you object to the deletion and instead request the restriction of the use of that data,
- if we no longer need the data for processing purposes, but you request it for the purpose of establishing, exercising and defending legal claims,
- if you objected to the processing;
- the right to data portability you have the right to receive your personal data that you have provided to us, in a structured, commonly used and machine-readable format, and you have the right to transfer this data to another controller, if the processing is based on consent or a contract and is carried out by automated means;
- the right to object you can object to the processing of your personal data at any time.
- the right to complain if you believe that by processing your personal data we have violated REGULATION (EU) 2016/679 OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL or other regulations regarding the protection of personal data, please contact our Personal Data Protection Officer to clarify disputed issues. #### **COOKIES (Cookies)**
